Building and encouraging relationships between Aboriginal and Torres Strait Islander Peoples and organisations in the Moreton Bay and North Brisbane community,

Committing to provide opportunities for all staff and volunteers in order to raise Aboriginal and Torres Strait Islander Cultural Awareness.

Developing Opportunities within our organisation and its services in collaboration and consultation with Aboriginal and Torres Strait Islander People that will improve socio-economic outcomes for those Peoples and communities.

Recognising that in order to meet one of the significant visions for Reconciliation, which is to improve overall status of Aboriginal and Torres Strait Islander People, the organisation needs to facilitate and encourage access to its community services.

Improving organisational service delivery, so as to meet the identified needs of Aboriginal and Torres Strait Islander people, within the extended Moreton Bay Region and Brisbane North area.


Acknowledging that achieving best outcomes will require a combined effort from a range of services and sectors and is committed to developing effective partnerships at national, state, regional and local level.

Supporting and encouraging the ongoing need for Aboriginal and Torres Strait Islander Peoples to engage and participate in areas of planning and development of community services that contribute to improving indigenous outcomes.

Recognising the positive impact on the socio-economic outcomes of Aboriginal and Torres Strait Islander families where Aboriginal and Torres Strait Islander employees are part of the community service delivery; and where Aboriginal and Torres Strait Islander Peoples are involved in planning and implementing services.
